In the case where both parents meet different steps of the activity test, the parent with the lowest entitlement determines the hours of subsidised care for the child.*
- Child of a shift worker of satisfy the work/ training/ study test
- Aboriginal & Torres Strait Islander Families
- Families which include a disable person in the household
